Please read the following instructions carefully before registering.

1. Applicants must apply online through the website www.lpggasdealerchayan.com. Applications received through any other mode would not be accepted.
2. Applicants must have a valid email address and mobile number.
3. All **Scanned images must be in .jpg/jpeg format only and the size of each document must not exceed 100 KB**. DON'T HAVE TO UPLOAD ANY OTHER DOCUMENTS OTHER THAN THE ID PROOF, ADDRESS PROOF AND PASSPORT SIZE PHOTOGRAPH.
4. Applicants are required to upload documents like Property Documents, Leased Agreement etc. under "UPLOAD DOCUMENTS" button only after successfully selection for the lpg gas agency dealership.
5. Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central/State Board indicating Date of Birth in support of claim of age. Where date of birth is not available in certificate/mark sheets, issued by concerned Educational Boards. (Applicants are required to upload this document only after successfully selection for the dealership).
6. Caste certificate by applicants seeking subsidy as SC/ ST/ OBC, in the prescribed proforma from the competent authority indicating clearly the candidate's Caste, the Act/ Order under which the Caste is recognized as SC/ ST/ OBC and the village/ town the candidate is ordinarily a resident of. **(Applicants are required to upload this document only after successfully selection for the petrol pump dealership).**
7. Applicants who wish to apply for more than one location should apply separately for each location and with new email id and pay the fee for each location in the prescribed manner.
8. The applicants are advised to submit the Online LPG Gas Agency Dealership Application well in advance without waiting for the closing date.

IMPORTANT : APPLICANTS ARE ADVISED TO FILL THEIR CORRECT AND ACTIVE EMAIL ADDRESSES IN THE ONLINE APPLICATION AS ALL CORRESPONDENCE WILL BE MADE BY THE LPG GAS AGENCY THROUGH E-MAIL ONLY.
